- Grievance The Union is still filing grievances; hoping they will be heard by the end of June.
- Labour Management They have less information about bargaining than the Union has. There were also no TDSB representatives at the Central Table.
- PSSP AGM is June 18. Harvey Bischoff will be attending and will be able to discuss details and answer questions about bargaining. Please remind members about the AGM.
- The Union is currently dealing with a lot of member issues.
- After a telephone Town Hall discussion and Q&A, announcing the Finance Committee's and the Executive's endorsement, an office condo unit was bought with a closing date is May 28, 2015. It is located near York Mills and Don Mills: 255 Duncan Mill Rd, Unit 404. It is accessible and comes with one parking space. Savings to the BU are anticipated and was the reason the Finance Committee began their search for alternate

office space. The purchase also coincides with a new regulation passed in March 2015 at AMPA (Annual General Meeting of the Provincial Assembly) that all OSSTF units must identify the specific purpose for any funds held that are greater than immediate operating costs.

#### 6. Vice President Report:

- 3 members are currently at home.
- The FTE (full time equivalent) has increased to 797 members.
- Members have been calling with concerns about crossing picket lines if Elementary Teachers go on strike due to the upcoming job action by ETFO starting on May 11. Direction was given via an email to all members regarding our ability to support colleagues on strike during our breaks and before and after our work hours.
- AGM June 18 Motions are going out on Friday, May 15. Members have been informed that they have until that date to get their bios in the On Time Package, but have until June 12 at 5 p.m. to send their bio to the Bargaining Unit office if they plan to run. After June 12, members can run from the floor only if a vacant position is available.
- Local Table Bargaining The brief has been created with the Table Team. The Union is currently waiting for final approval from our provincial office bargaining rep.
